# **C2C:** Moving Forward

mid-December 2009, the Connecting to Collections (C2C) Steering Committee submitted an implementation grant application for \$743,209 to the Institute of Museum and Library Services (IMLS) for a two-year project to collaboratively develop emergency and collections plans for Florida's cultural heritage institutions. This application was a follow-up to an IMLS planning grant that was awarded to Florida in 2008. As part of the planning grant activities, a statewide survey of collections needs was conducted from August through November 2009. Unfortunately, the Steering Committee learned in mid-April of this year that Florida did not receive the implementation grant. Awards were made to Rhode Island, California, Connecticut, Delaware and North Carolina. While grant reviewers noted that it was a well thought out proposal, reflected strong collaboration among multiple groups, and addressed funding concerns very well, they felt it would have been stronger if the implementation grant had included a final report of the previous IMLS planning grant survey findings. IMLS staff could not provide a list of applicant organizations and where Florida ranked in the review, as this was not considered public information.

The C2C Steering Committee held a conference call on June 28. Participating in the call were Burt Altman, Daniel Stetson, John Maseman, Malinda Horton, Melissa Kendrick, Myriam Springuel, and Russell Daws. The Committee reviewed and discussed a preliminary draft of the planning grant survey report and agreed that it should be written so that many institutions (not just the C2C project) could use the report and its data to argue for collections preservation. Examples of the kind of information the Steering Committee hopes to see in the final report include the following:

The report showed that only 25% of photographic collections are stable with the rest needing conservation in the state. Could an analysis be made of all collections, as well as an analysis by type?

- The fact that 75% of collections are accessible to the general public, 85% to scholars, and more than half of collections have finding aids demonstrate that collections serve the public.
- 75% of collections do not have sufficient humidity controls which is "an invitation to damage" and part of a call for taking action.
- Where analysis is provided, it would be helpful to compare these statistics to the HHI so Floridians can understand how they compare to the nation.

Steering Committee members decided to review a draft of the data via conference call in order to provide specific feedback to survey designers Dr. Paul Marty and Kathy Braun and to assist them in focusing the report. The Committee initially planned to hold the call in mid-July so the report could be completed before the start of the academic year.

At the Committee meeting, we also learned that the Texas State Library and Archives Commission was awarded \$674,000 (\$207,000 matching) C2C: Continuing Conversations grant to lead a team of partners representing statewide collaborative projects (American Association for State and Local History, Clemson University; Florida Association of Museums; Maine State Museum; Newark (NJ) Museum; Washington State Library; Oklahoma Dept of Libraries; South Dakota State Historical Society; Board of Library Commissioners for the Commonwealth of Massachusetts) that will work with IMLS to develop the C2C Continuing Conversation Exchange, a series of meetings planned, managed and hosted by recipients of C2C Statewide Planning Grants. It was noted that Florida's participation in this initiative underscores the importance of C2C to the state and should help strengthen Florida's re-application to IMLS. This fortuitous development also underscored the importance of a survey report to share with colleagues nationally.

### **NEXT STEPS**

Steering Committee member Russell Daws reported that the FAM Board at its last meeting recommended that the C2C implementation grant proposal address the concerns raised in the reviewer comments. Their board recommended resubmitting the collaborative application to IMLS. While there was some discussion about rethinking the project and applying for grants by discipline or by region, FAM did not have the resources to pursue that route now.

The Steering Committee concurred with the FAM Board recommendations and added that the IMLS grant application should be submitted when the Survey Report is complete. The Committee agreed that the next steps are to:

- Finalize the survey report
- Myriam Springuel, FAM Foundation program manager, and Malinda Horton, FAM Foundation executive director, were asked to confer with IMLS staff about any additional input for the next application
- Schedule a Steering Committee conference call with Dr. Paul Marty and Kathy Braun to review the draft report
- Revise and resubmit the application





# **SUPPORT ARCHIVES IN HAITI**

Following the devastating earthquake in Haiti in January of this year, SFA members began discussing ways in which to provide support to the archival repositories there. News of the earthquake's impact on those repositories arrived almost immediately from Brooke Wooldridge, director of the Digital Library of the Caribbean, who disseminated photos and publicized the need for archival supplies to protect the endangered collections at the Haiti National Archives, National Library and the Fathers of the Holy Spirit and Christian Brothers. Brooke has spent the past six months coordinating the effort to collect and deliver supplies to Haiti by contacting numerous organizations and companies internationally. I am happy to report that although it has taken several months, we are at last ready to provide direct support to Haitian archives.

During the annual SFA business meeting in Tampa in May, attendees discussed the situation and brainstormed ways of helping. Since many of our members know and have worked with archivists and librarians in Haiti and many of our own repositories hold materials pertaining to Haiti, there was strong agreement among those at the meeting that we should provide support in some way. Following that meeting, I received additional ideas and comments from members via e-mail, as well as offers to contribute both supplies and funds. Larry Gates, president of Hollinger Metal Edge, also responded saying that his company would donate hundreds of archival boxes to the effort. Please join me in thanking Larry and Hollinger Metal Edge for this generous offer!

In a telephone meeting on June 17, the SFA board passed a motion stating that SFA will contribute \$500 to help pay for shipping costs and the purchase of additional supplies. We're calling on our membership to match the \$500 SFA is contributing. The Board has established a special account to collect funds for delivering supplies to Haiti and we hope to exceed our goal of \$1,000. Please make your check payable to the Society of Florida Archivists and in the memo note indicate "Haiti Support."

## **ARCHIVAL EDUCATION NEEDS SURVEY**

Over the past few years, several Florida institutions have partnered in an initiative called **Opening Archives in Florida**, which provides training to archivists and others who work with archival materials. In December 2009, the Opening Archives team was awarded an NEH Preservation and Access Education & Training Grant to support our statewide education and training program, *Advancing Access and Preservation Best Practices in Florida*. This project, which the SFA co-sponsors, provides training through a series of four free Society of American Archivists (SAA) workshops.

A key part of this project will be a survey to determine archival education needs and priorities. The Opening Archives team has developed an education needs survey that examines current barriers to archival training and asks respondents to prioritize topics for future workshops. The survey will be disseminated online in mid-July and it is important that SFA members respond to this survey. Your responses will support and guide future archival education activities in Florida. The online survey will be posted on the Opening Archives page at <a href="http://fclaweb.fcla.edu/Opening Archives">http://fclaweb.fcla.edu/Opening Archives</a>, and we will send the link to SFA members via email.
